The Commodity Futures Trading Commission's rewrite of their trade reporting rules (CFTC Rewrite) is the most significant amendment to reporting rules in the US since over-the-counter (OTC) derivatives reporting was first implemented by the CFTC under the Dodd-Frank Act in 2012. Scheduled for implementation on December 5, 2022, key changes include updated data submission requirements, timing of reporting and data verification requirements. This will likely create challenges for firms as they ready their systems for compliance with the new rules.
